I hereby grant to International Youth Silent Film Festival ("IYSFF"), for the benefit of IYSFF and its affiliates, licensees and distributors, the non-exclusive, worldwide, royalty-free, irrevocable, perpetual, transferable, sub-licensable right to use my film and all other submitted materials, including my name, image, likeness and biographical information (collectively, the "Submission"), including the right to reproduce, publish, distribute, publicly display, modify and prepare derivative works, in any manner or media, including commercially or otherwise. IYSFF has no obligation to use or display the Submission. Although I may receive an award for my participation, I will not receive any other compensation for my participation.

I represent and warrant that I own all right, title and interest in the entire Submission and that the Submission is original work and does not infringe the copyrights or other proprietary or privacy rights of any third party. I will indemnify, defend and hold harmless IYSFF and the Released Parties from and against all damages, costs, and fees (including attorneys fees) asserted by anyone for actual or alleged infringement or misappropriation of any intellectual property, privacy or other right by me.

3. This Agreement shall be governed by the laws of Oregon, USA. All actions arising out of or in connection with this Agreement shall be brought in courts in Portland, Oregon and I submit to the exclusive personal jurisdiction of such courts. I agree that a final judgment in any such action shall be conclusive and may be enforced in any other jurisdiction.
